

STATEMENT OF COMPLIANCE with the PRE-RELEASE ACCESS TO OFFICIAL STATISTICS ORDER (NORTHERN IRELAND) 2009

Introduction

The statement sets out Libraries NI's operational arrangements for giving Chief Executives and their briefing officials pre-release access to official statistics once they are in their final form prior to publication. These arrangements are designed to ensure that such access is justified, limited, controlled and publicised and complies with statutory requirements.

Their purpose is to maintain public confidence in the integrity of official statistics while also allowing Chief Executives to comment immediately on the implications of statistics covering policy areas for which they themselves are responsible.

This statement is published in conformance with Paragraph 9 (c) of the Pre-release Access to Official Statistics Order (Northern Ireland) 2009 which was approved by the Assembly under Section 11 of the Statistics and Registration Service Act 2007 and which came into effect on 1 April 2009.

Exclusion

Different arrangements apply to Chief Executives' and officials' access to administrative or management data where those data subsequently form the basis for published official statistics. Details of these arrangements can be found in the National Statistician's guidance at the link below:

Authority

These arrangements have been drawn up by Libraries NI's Lead Official for Statistics (LO) in consultation with the senior statistician in the sponsor Department (i.e. Department for Communities, DfC). In Northern Ireland, as at UK level, decisions on pre-release access will, in practice, be led by statistical professionals. Under the Statistics and Registration Service Act 2007, it is ultimately the responsibility of the 'person responsible' for an official statistic to determine pre-release access to that statistic. The person responsible is the Chief Executive in charge of an Arm's Length Body (ALB), for official statistics produced by that ALB. However, in order to distance

the decision making on pre-release from Chief Executives of ALBs, LOs in ALBs have a central role in carrying out the responsibilities within the Order, with support from Chief Executives and Directors of ALBs, and advice and guidance from senior statisticians in the sponsor Departments and the Chief Executive of the Northern Ireland Statistics and Research Agency (NISRA) as required. This means that in practice, the decision making process for pre-release access, including ensuring awareness of the rules, monitoring compliance, determining which statistics are eligible for pre-release and who gets pre-release access, is being led by LOs in ALBs. These activities will be assessed by the UK Statistics Authority for compliance.

General Principle

Libraries NI operates under the general principle that pre-release access to official statistics must be:

- limited to the minimum number of persons deemed necessary to allow the Chief Executive of Libraries NI to either:
 - provide responses to questions, or make statements about those statistics at, or shortly after, their time of publication;
 - o take action just before, at, or shortly after the time of publication.
- allowed in those circumstances where the public benefit likely to result from such access outweighs the detriment to public trust in official statistics likely to result from so doing.

Grant of advance access

The arrangements set out in this statement are confined to those persons who meet the eligibility criteria set out in Appendix 1 (i) attached. Recipients can, in addition, share their access with their immediate administrative support staff even though those staff may not directly engage with the statistics in question. Their advance access is limited to statistics which meet the eligibility criteria set out in Appendix 1 (ii) attached, and which are in their final form prior to being published for the first time.

Documentation and Publication

In the interests of openness and transparency, Libraries NI maintains a public record on its website listing the titles of all the statistical releases to which these arrangements apply, as well as the job titles of all those persons to whom prerelease access has been granted, and the organisations to which they belong.

Period of access

In line with the legislation, pre-release access to Libraries NI's official statistics is restricted to a maximum of 24 hours before their public release on the following day – usually at 09.30.

In exceptional circumstances only, and in accordance with Principle 5 of the Prerelease Access to Official Statistics Order 2009, the LO may grant pre-release access in excess of 24 hours. They will only do this if, in their opinion, the public benefit outweighs the detriment to public trust which is likely to result from such extended access. When this happens, the LO will publish on the Libraries NI website their reasons for granting extended access, and will also inform the UK Statistics Authority.

Conditions of access

Those persons who are given access to Libraries NI's official statistics ahead of their release must keep the statistics secure and under embargo, and they must abide by the following conditions of access. They must avoid:

- disclosing the statistics or any part of a publication containing those statistics to any person not listed as a pre-release recipient;
- providing any indication of the size or direction of any trend revealed by the statistics;
- using such access for personal gain, or taking any action for political advantage;
- exploiting such access to change or compromise the content, presentation, or timing of publication of official statistics.

Special Circumstances

Aside from the circumstances described above, the LO may also allow access to statistics ahead of their release to a limited number of persons in a limited number of special circumstances, sometimes for more than 24 hours. In each case, such access will be documented in the relevant release. For example:

- access may be given to the compilers of complementary reports due to be published at the same time as, or shortly after the statistics so that they can incorporate the latest available figures. Such access may also be longer than 24 hours:
- international organisations may gain access in order to compile supra-national statistics; and
- in exceptional circumstances, pre-release access may be extended to someone who is not an 'eligible person' as defined in the Order. In which case the UK Statistics Authority will be informed and the reason for such exceptional access published.

Breach of conditions of release

In the event of Libraries NI becoming aware of a breach of the principles and rules set out in the legislation and described in this statement, the LO will notify the Chief Executive of NISRA (through DfC's senior statistician), who will in turn consider the

need to notify the Chair of the UK Statistics Authority. In the event that this is necessary, the Chief Executive of NISRA will write to the Chair of the UK Statistics Authority regarding the breach using the Authority's standard reporting form. The Chair of The Authority may invite the LO of Libraries NI to prepare a report for the Statistics Authority.

Where the LO considers that a breach was minor in nature, and resulted in no damage to the integrity of the statistics involved, the LO may choose to deal with the matter informally through internal discussion.

Sanctions against non-compliance

The LO may, for a period, withdraw pre-release access from any person judged to have breached the conditions of their access.

In addition, a heavier sanction can be imposed by the UK Statistics Authority which has a statutory duty to assess the extent to which any organisation's 'National Statistics' comply with the Pre-release Access to Official Statistics Order (Northern Ireland) 2009 and with the associated obligations set out in this Statement. The Authority can, for instance, challenge an organisation where it considers that pre-release access is not justified or where an organisation is failing to conform to these arrangements. It can also withdraw, or consider withdrawing, 'National Statistics' designation from the statistics in question. In the event of any such challenge or withdrawal the LO will publish Libraries NI's response or reaction on its website along with its plans for achieving conformance.

DEFINITIONAL NOTES:

(a) Pre-release access

In the context described above, the phrase 'pre-release access' covers privileged access to statistical releases in their final form prior to being placed in the public domain. It does not cover pre-release access available to:

- those staff intimately engaged in the process of producing and disseminating the statistics in question (including those responsible for overseeing this process);
- those persons requested by the producers of statistics to quality assure the statistics before their public release.

However the restrictions listed under 'Conditions of access' above do apply to the above.

(b) Senior Statistician

Departments/bodies which employ a large number of government statisticians or produce a large number of official statistics will normally appoint a senior statistician. In DfC (i.e. the sponsor Department of Libraries NI) the senior statistician is the Head of Professional Services Unit.

(c) Lead Official for Statistics (LO)

Arm's Length Bodies (ALBs) which have been designated as producers of official statistics under the Official Statistics Order (Northern Ireland) 2012 will normally appoint a Lead Official for Statistics (LO). In Libraries NI the LO is the out-posted NISRA Statistician.

APPENDIX 1 - Criteria for Granting Pre-Release Access

- (i) Categories of persons within government to whom Libraries NI would normally grant pre-release access to its statistical releases:
 - Those Chief Executives who have operational responsibility for the activities
 covered by a statistical release, and who are accountable for stewardship of
 that activity to Ministers, and through them to Parliament/the Assembly; and
 who may need to respond to questions about the statistics, or take
 appropriate action, at the time of release of those statistics;
 - The ALB officials with ultimate responsibility for formulating, developing, maintaining, monitoring or implementing those activities;
 - Other ALB officials who have been assigned the specific responsibility to brief Chief Executives or Directors about the statistics in question;
 - ALB Communications Officers responsible for managing Chief Executives' interface with the media with respect to the policy or statistics in question.

(plus any immediate ancillary staff who support the above)

- (ii) Categories of statistical release to which Libraries NI would normally grant prerelease access:
 - Releases categorised as 'Market-sensitive' (i.e. releases which embody statistics which, when disclosed, would be reasonably likely to have a significant effect on the value or traded volume of any investment);
 - Releases which incorporate statistics which are used to monitor or measure the government's performance (either generally, or against formal targets);
 - Releases which have the potential to impinge substantially on the formulation, implementation, or monitoring of government policy;
 - Releases which have the potential to inform, or impact on, decisions about the allocation of public funds;
 - Releases which have, demonstrably and historically, had a high public profile
 (i.e. regularly generate column inches in the print media or regularly attract
 the attention of the broadcast media) and on which Ministers or Chief
 Executives with responsibility for the subject-matter might reasonably be
 expected to comment at the time of release;
 - Releases which incorporate statistics derived from other departments' or agencies' administrative or management systems, and for which Ministers or Chief Executives in those other departments have ownership and operational responsibility;
 - Compendia or complex publications; and
 - Releases which cover matters of wide public interest.
