# Libraries NI - Lone Working Policy

# 1. Introduction

- 1.1 The Lone Working Policy and Procedures apply to all staff, volunteers and other work related placements.
- 1.2 The Lone Working Policy and Procedures were agreed between Management and Trade Union representatives of the Negotiating Committee for Libraries NI
- 1.3 Libraries NI recognises that lone working is a necessary part of service provision as some libraries do not attract a level of use which would justify having more than one member of staff in place throughout library opening hours.
- 1.4 Working alone is not against the law and it will often be safe to do so. However, the law requires employers and others to think about and deal with any health and safety risks before people work alone.
- 1.5 Libraries NI is committed to ensure the safe working practices are in place for staff who work alone. Any library where lone working occurs will have the risks associated with this assessed and appropriate controls put in place. A risk assessment will be carried out and appropriate controls put in place before any member of staff is requested to work alone.
- 1.6 Libraries should only be single staffed where circumstances mean that this is the most effective way to provide a service.

# 2. Purpose

2.1 The purpose of this policy is to set out Libraries NI's approach to lone working.

Libraries NI will:

• address the safety and wellbeing of staff who work alone.
