What is it trying to achieve? (intended aims/outcomes) <i>The Smoking (N.I) Order 2006 came into effect from Monday 30 April 2007. The legislation requires that all “enclosed” and “substantially enclosed” workplaces, public places and certain vehicles are smoke free. All Libraries NI premises are therefore required to be smoke free workplaces and this policy sets out the approach Libraries NI takes to complying with these requirements.</i>
Are there any Section 75 categories which might be expected to benefit from the intended policy? If so, explain how. <i>The policy offers the same benefits (smoke free workplace/premises) to all persons using library services irrespective of their status in relation to section 75 categories.</i>
Who initiated or wrote the policy? <i>The policy was initiated by a statutory requirement to comply with The Smoking (N.I) Order 2006 and all subsequent legislation made under that Order. The policy has been drafted by the Libraries NI Assets Manager on behalf of the organisation.</i>

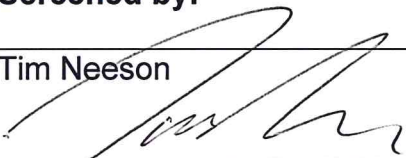
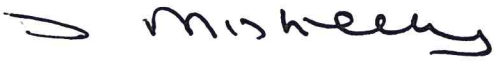
